NW A Street – Fire Building/City Hall – Jeff Doris Ron Lehman stated that Mr. Doris is still working on the building at this time. Ron will continue to give updates.

400 N.W. I St – Clarence W. Adams Jr. & Darlene Ron Lehman reported that nothing has changed as far as cleaning up the property. Sam Drummy stated that he will send a notice of the fine to Mrs. & Mrs. Adams.

642 N.W. "E" Street - Joe Hineman Properties—22092008
