#### **Blighted Properties**

68th NW – James Anderson (Alva Anderson Life Estate)

Property has been cleaned up. The city has not received an invoice from Carr-Thomas. Clerk-Treasurer Claudia Walker spoke with Carr-Thomas, and they will be submitting an invoice. Sam Drummy asked the Clerk-Treasurer to forward the invoice to him once she received it and will assess costs at the next meeting.

### 13th St NW - Dominick Iacobazzi

Mr. Iacobazzi was present at the meeting. Mr. Iacobazzi stated he has been working on cleaning up the property. Tony Richards told Mr. Iacobazzi that the board has given him several months to clean up the property. Ron Lehman stated that the car needs to be removed and the first trailer setting on the property is a health hazard. Sam Drummy stated that the city had sent Mr. Iacobazzi a letter stating the deadline was today at 4:00 pm. After discussion it was decided to give Mr. Iacobazzi another extension by the September 3<sup>rd</sup> meeting. Ron will get bids during this time for cleanup for the next meeting. A motion was made by Tony Richardson to extend the deadline to September 3<sup>rd</sup> and 2<sup>nd</sup> by Mayor Preble. 3 Ayes, passed.

# 48 6th St SE - Bobby Piker

Ron Lehman stated that Mr. Piker has a contractor working on his house and there is a contractor tearing the roof off on the property next door. Property will stay on the agenda for next month and will continue to be monitored.

### 159 3rd St SE - Melissa & Thomas Gordon

Ron Lehman stated that nothing has been done to the property. Mayor Preble stated that Mr. Gordon had contacted city hall to let him know he was out of state and asked if he could have an extension. Mayor Preble stated he did not grant the extension but noted that nothing would be done until next month. A bid was opened from Carr-Thomas for \$6,950 plus \$200.00 a 20-ton load for fill dirt.
